

Sprint Discount Program Eligibility Verification Form for Credit Union members



Sprint is pleased to offer monthly discounts to Credit Union members.

Use your phone and skip this form. Verify your Credit Union membership on your smartphone with the **Love My Credit Union Rewards app** – available in the iTunes App Store and the Google Play Store. If you use the app to quickly verify your membership, then there is no need to complete the form below.

Please complete these important steps to submit proof of eligibility online or by fax.

1. Confirm your discount eligibility by uploading or faxing proof of your active membership status.

Submit a copy within 30 days of **one** of the following items that clearly shows your name and the name of your Credit Union and any applicable dates. **Write your Sprint wireless number on each page you fax to Sprint.**

Cover, delete or black out all sensitive information, such as Social Security number, financial institution account numbers, credit card numbers and salary detail. Sprint is not liable for confidential information.

Check the item you will be submitting below:

- Screen shot or scan of an Account Statement within the last 90 days Credit Union check
 Unexpired Credit Union debit or credit card Credit Union membership card

Business cards or letterhead are not acceptable items for showing eligibility.

Participation in the Sprint Discount Program is subject to continued verification under your Credit Union's Service Agreement with Sprint. Failure to demonstrate eligibility for your Credit Union may result in charges for benefits you are not eligible to receive. Discount subject to change according to the Credit Union's agreement with Sprint and is available upon request for select monthly service charges. Discount only applies to data service for Sprint Family Share Pack and Unlimited, My Way plans. Discount is not available with no credit check offers or Mobile Hotspot add-on. Discount may also apply to select previously available services where specified.

2. Send proof of eligibility within 30 days to Sprint.

3. Check your account status at sprint.com/verify after 3 days.

Once we validate your information, the discount will appear on your invoice in 1 to 2 billing cycles. If you provided a valid email address you will receive a confirmation email from us.

You will not be considered affiliated with your organization's account or Service Agreement and will not receive any service plan discounts until Sprint receives and validates your Sprint Discount Program Eligibility Verification Form and proof of eligibility. Please direct questions about your discount eligibility to your membership organization. Sprint is unable to issue retroactive credits.
